Some states are currently imposing a Retail Delivery Fee (RDF) on deliveries.


This new enhancement provides the option in the order or quote entry process to automatically calculate and apply a Retail Delivery Fee as a flat rate extra charge based upon the parameters defined for the extra charge code and customer (with defaults set in SOP.CONSTANTS).

A new report function RDF.REPORT was added to collect/report the fee(s) to aid in state filing requirements.
